1 **Project Description**

The proposed revamped NKF HQ Building shall optimize space to house the following area:

- The Chairman & CEO's Office
- Common meeting / discussion rooms at each level
- Common hot-desking distributed at Levels 5 to 7 and roof-top
- Existing dialysis centre (optional)
- A new dialysis treatment for non-ambulant patients at the ground level
- Car Park space optimisation

4. SCOPE OF CONSULTANCY SERVICES

- 4.1 The Architectural Consultant (ARC) is required to work in tandem with the Design Consultant & multi-disciplinary team of civil & structural engineer, M&E engineers and other contractors to ensure the most cost effective and efficient design within the constraints of time, quality and budget is achieved.
- 4.2 Note the Architectural scope of services shall include the Interior Designing services carried out by a separate entity or Company not owned by the Architectural Company. The Architectural scope shall also include landscaping design of the soft-scaping and hardscaping works.
- 4.3 Note the Mechanical & Electrical scope of services shall include supporting M & E services for the Security and IT-related works.
- 4.4 The ARC shall also act as the Consultant Project Manager.

5. PROJECT COST

The construction cost of the project is estimated in the region of \$_____. Upon appointment, the ARC shall proceed to determine the Overall Development Cost and the likely construction cost.
