

TENDER NO. 20210201 TENDER FOR THE PROVISION OF BIOHAZARDOUS WASTE COLLECTION AND SAFE DISPOSAL SERVICES TO NKF

REQUIREMENT SPECIFICATIONS

1. Introduction

1.1 The National Kidney Foundation ("**NKF**") wishes to appoint a contractor (the "**Contractor**") for the provision of biohazardous waste collection and safe disposal services to NKF as described in these Requirement Specifications (the "**Services**") to all its dialysis centres in Singapore.

2. Requirement Specifications

- 2.1 The participating Contractor must be a registered toxic industrial waste collector with the National Environment Agency (NEA) to collect and dispose pathogenic waste. The Contractor shall conform to the detailed scope of service and requirement in **Annex A**.
- 2.2 The **Services** shall be delivered to NKF's dialysis centres as NKF shall stipulate from time to time. Please refer to **Annex B1-B2** for the detail list of NKF's Dialysis Centres (as at date of this tender). For the avoidance of doubt, NKF reserves the right at any time to increase or decrease the number of and to vary and / or change the location of any or all of the listed Dialysis Centres.
- 2.3 The participating Contractor must have relevant experience in the collection and disposal of biohazardous waste from hospital, medical centres, dialysis centres or healthcare instituitions.

3. Quantity requirements and delivery requirements

- 3.1 The Contractor shall supply the Services over a period of **twenty-four (24) months, from September 2021 to August 2023** subject to such extensions of the period of appointment by NKF in accordance with the Conditions of Contract.
- 3.2 NKF's estimated requirement for the Services over a period of twenty-four (24) months is set out below:
 - 3.2.1 An estimated number of 240 litre bins to be collected per month: **1,600**
 - 3.2.2 Frequency of collection per dialysis centre shall be:
 - (a) at least 2 times weekly
 - (b) 3 times weekly for CLE, PNG, JW1, QT1 and SMI
 - (d) as requested by NKF

4. Term of Contract

4.1 The contract shall commence on the date stated in the Letter of Acceptance and shall remain in force for a period of **twenty-four (24) months** with the NKF



- having an option to extend for further periods of twelve (12) months each on the same terms and conditions as stated in the Contract (as may be amended, varied, supplemented and/or replaced from time to time).
- 4.2 Unless otherwise stipulated by the NKF, all purchases for the Services made during the extended period of this Contract shall be subject to the terms and conditions hereof (as may be amended, varied, supplemented and/or replaced from time to time), and the Services purchased during such extended period shall be deemed to be Services as defined in this Contract.

5. Submission of tender bids

- 5.1 Each Tenderer should provide the price quote in the Price Schedule.
- 5.2 All quotations submitted by the Tenderer must indicate the prices applicable for the Requirement Specifications specified in paragraph 2 above.
- 5.3 The Tenderer, at the point of submission of its bids, is required to provide the following information and/or documents to NKF:
 - 5.3.1 Copy of toxic waste collector's licence from NEA (for pathogenic waste)
 - 5.3.2 Copy of transport approval from NEA for the transportation of toxic waste
 - 5.3.3 Track record stating the length of service, description of service, contract value and contact details of the customer (Reference check may be conducted on the references)
 - 5.3.4 Documents stated in the "Information About Tenderer" (point 7)

ANNEX A

SCOPE OF SERVICE

- 1. To provide sufficient 240 litres bin for the storage of biohazardous waste to the dialysis centres as listed in **Annex B1 B2**.
- 2. Frequency of collection will be at least **thrice a week** for CLE, PNG, QT1, JW1 and SMI centres, **and twice a week** for other dialysis centres unless otherwise mutually agreed by NKF.
- 3. Vendor shall prepare the NEA prescribed E-Tracking consignment note for collection of the bio hazardous waste disposal.
- 4. Vendor shall provide item (a) and (b) every monthly and the estimated quantity over 2 years are as follows:

a)	Yellow bio hazard bag	0.03mm x27" x36"	4,000 packets of 100s
b)	Yellow bio hazard bag	0.018mm x19" x19"	13,600 packets of 100s

5. Estimated total number of biohazardous bin collection for a period of 2 years is **38,000**.
