

**TOKEN OF APPRECIATION FOR

**TERMS AND CONDITIONS**

**1. Eligibility**

1.1 The draw of Token of Appreciation for NSD ("The Draw") will be conducted by The National Kidney Foundation ("NKF") and is open to all persons who have made a donation towards NSD via NSD donation envelopes.

**2. Qualifying Period and Draw Date**

2.1 The Draw Date will be on ~~25 August 2021~~ **29 September 2021** ("Draw Date") and the qualifying period for The Draw is from 8:30 a.m., ~~30 January 2021~~ to 11.59 p.m., ~~30 June 2021~~ **2 August 2021** ("Qualifying Period").

2.2 Unless NKF notifies otherwise, The Draw will be conducted on the Draw Date at 3.00 p.m. ("Draw Time") for one hundred (100) tokens of appreciation. The Draw will be conducted at NKF Centre, 81 Kim Keat Road, Singapore 328836 or at such other venue as may be deemed appropriate by NKF at its absolute discretion.

2.3 The winners will be notified through the school / group in-charge via email within 14 working days from the Draw Date."

**3. Consent**

3.1 NKF will collect, use and disclose the personal particulars collected for processing of donations. In addition, the participant's name, school/organisation, reflections on challenge and encouragement notes to patients may also be used in NKF's promotional and informational materials.

3.2 Each participant also agrees that photographs, audio-video or other recordings taken during prize collection can be used by NKF for publicity purposes, as deemed fit.

**4. Token of appreciation**

4.1 A hundred (100) tokens of appreciation will be issued as prizes.
